Job purpose

The post holder is responsible for the delivery of training and mentoring, primarily for practitioners in post-14 education, including schools, further education colleges, and apprenticeship providers, on aspects of bilingual teaching.

Main duties and responsibilities

1. Programme Lead for the Sgiliaith Bilingual Education Methodology MA Module.
2. Contribute to planning a variety of professional development courses in bilingual teaching and assessing
3. Contribute to practitioner training and the provision of resources (eg Practical Toolkit on Bilingualism, Cymraeg Gwaith Scheme, individual college PGCE courses, Bilingual Teaching Methodologies courses)
4. Take responsibility for mentoring staff, individually and in groups, on aspects of bilingual teaching and assessing
5. Contribute to discussions with establishments about professional development needs in bilingual teaching and assessing
6. Promote and market the training courses and the mentoring program and recruit practitioners to participate
7. Achieve targets and provide information on progress towards targets as required
8. Collaborate closely with the Coleg Cymraeg Cenedlaethol and attend regular monitoring meetings
9. Contribute to other projects as required
10. Collaborate effectively with members of the Sgiliaith team and attend team meetings as required
11. Represent Sgiliaith in internal and external meetings and forums as required
12. Any other duties which are compatible with the post, at the request of the Head of Sgiliaith
